as provided by Mean Well Enterprises Co., Ltd. hereinafter referred to as ("Mean Well Enterprises"), No.28, Wuquan 3rd Rd., Wugu Dist., New Taipei City 24891, Taiwan (R.O.C.), in the GHG Assertion in the form of GHG report covering GHG emissions of the period 01 January 2021 to 31 December 2021.

#### Roles and responsibilities

The management of Mean Well Enterprises is responsible for the organization's GHG information system, the development and maintenance of records and reporting procedures in accordance with that system, including the calculation and determination of GHG emissions information and the reported GHG emissions.

It is SGS's responsibility to express an independent GHG verification opinion on the GHG emissions as provided in the GHG Assertion for the period 01 January 2021 to 31 December 2021.

SGS conducted a third-party verification of the provided GHG assertion against the principles of ISO 14064-1:2018, ISO 14064-3:2006 in the period 20 September 2022 to 29 September 2022. The verification was based on the verification scope, objectives and criteria as agreed between Mean Well Enterprises Co., Ltd. and SGS on 02 November 2021.

#### **Level of Assurance**

The level of assurance for category 1 and category 2 agreed is that of reasonable assurance. Category 3 till category 6 agreed is that of limited assurance.

#### Scope

Mean Well Enterprises Co., Ltd. has commissioned an independent verification by SGS Taiwan of reported GHG emissions of Mean Well Enterprises arising from Design, Manufacturing and Sales of Switching Power Supplies activities, to establish conformance with ISO 14064:2018 principles within the scope of the verification as outlined below.
